### Suggested Application Rates:

Apply 10 lbs. of TruLime per 1,000 ft<sup>2</sup> once a month.

 Correctional guidelines for pH adjustment:

<u>Existing pH</u>	<u>Application quantity</u>
6.5-7 .....	apply up to 12 lbs. / 1,000 ft <sup>2</sup>
6-6.5 .....	12-25 lbs. / 1,000 ft <sup>2</sup>
5.5-6 .....	25-50 lbs. / 1,000 ft <sup>2</sup>
Below 5.5.....	consult with agronomist
