**Directions for Use:**

**Greens, Tees and Fine Turf:**

Apply 100 - 200 ml of **Green-T® Sugar Cal** with 6 - 8 litres of water per 100 m<sup>2</sup> (Apply 10 - 20 litres of **Green-T® Sugar Cal** with 600 - 800 litres of water per Hectare. every 10 to 14 days throughout the growing season.

**Fairways and Sports Turf:**

Apply 10- 20 litres of **Green-T® Sugar Cal** with 400 - 800 litres of water per Hectare (Apply 100 - 200 ml of **Green-T® Sugar Cal** with 4 - 8 litres of water per 100 m<sup>2</sup>) once or twice per month throughout the growing season. Applications that are more frequent may be required to correct deficiencies in the soil.
