Directions for Use:

Greens, Tees and Fine Turf: Apply 127- 255 ml per 100 m² (4.0- 8.0 oz./1,000 sq.ft.) of Green-T® 8-27-5 with 5.6 - 7.5 litre of water per 100 m² (1.5- 2 gal of water/1,000 sq. ft.).

Apply 13- 25 Litre per Ha (1.4 – 2.7 gal/Acre) of Green-T® 8-27-5 with 250- 333 litre of water per Ha (66- 88 gal of water/ Acre) every 10 -14 days throughout the growing season anytime additional phosphate and potassium are required and when Poa is showing signs of stress.

Fairways, Roughs, Sports Turf and Lawns:

Apply 13- 25 Litre per Ha (1.4- 2.7 gal/Acre) of Green-T® 8-27-5 with 167 - 333 litre of water per Ha (44- 88 gal of water/Acre).

Apply 127- 255 ml per 100 m² (4.0- 8.0 oz./ 1,000 sq. ft.) of Green-T® 8-27-5 with 3.78 -7.57 litres of water per 100 m² (1- 2 gal/1,000 sq. ft.) once or twice per month throughout the growing season.

Poa Health: Green-T® 8-27-5's available potassium and polyphosphate strengthen Poa roots and stimulate uniform turf color with bentgrass.

Mixing Handling:
