Green-T® Infiltrate-K 0-0-29 is a potassium acetate liquid that rapidly enters the foliar tissue. Due to its low burn potential, rapid leaf absorption, high potassium plant uptake and slow drying characteristics, applications of Green-T® Infiltrate-K 0-0-29 result in safer foliar applications and less stress on the plant.

The plant absorbs potassium from Green-T® Infiltrate-K 0-0-29 in much higher proportions than all other potassium sources due to its unique composition with acetates. Acetates, a component of the TCA cycle, have complexing qualities that help stabilize other nutrients with its buffering capacity. Acetates resemble organic acids that release nutrients which may be unavailable.

Directions for Use:

Greens, Tees and Fine Turf: Apply 64- 255 ml per 100 m² (2.0- 8.0 oz./ 1,000 sq.ft.) of Green-T® Infiltrate-K 0-0-29 with 5.6 - 7.5 litres of water per per 100 m² (1.5- 2 gal of water/ 1,000 sq. ft.). Apply 6 - 25 litres (0.7 – 2.7 gallons) of Green-T® Infiltrate-K 0-0-29 with 250- 333 litres of water per Ha (66- 88 gal of water/acre) every 14 days throughout the growing season.

Fairways, Roughs, Sports Turf and Lawns:

Apply 20 - 31 litres per Ha (2.0 – 3.4 gal/ 1,000 sq. ft.) of Green-T® Infiltrate-K 0-0-29 with 166 - 333 litres of water per Ha (44- 88 gal of water/Acre). Apply 191 - 318 ml per 100 m² (6.0- 10.0 oz./ 1,000 sq. ft.) of Green-T® Infiltrate-K 0-0-29 with 3.78- 7.57 litres of water per 100 m² (1- 2 gal of water/ 1,000 sq. ft.) every 2 to 4 weeks throughout the growing season.
