Potassium+, 0-0-25, 17% Sulphur is a neutral to basic, chloride-free, green liquid solution. It can be used as the sole potassium source with the additional benefit of sulfur to aid in more efficient nitrogen utilization. Potassium+, 0-0-25, 17% Sulphur may also be combined with nitrogen and phosphorous sources to supply the desired fertilizer blend for proper turf nutrition. Split the applications to coincide with the nutritional demands of the cultivars present.

Directions for Use:

Greens, Tees and Fine Turf: Apply 127 - 255 ml per 100 m² (4.0- 8.0 oz./ 1,000 sq. ft.) of Potassium+, 0-0-25, 17% Sulphur with 5.6 - 7.5 litre per Ha of water (1.5- 2 gals of water /1,000 sq. ft.)

Apply 13 - 25 litre per Ha (1.4- 2.7 gal/ acre) of Potassium+, 0-0-25, 17% Sulphur with 250-333 litre of water per Ha (66- 88 gal of water/Acre) every 14 days throughout the growing season on warm, transitional, and cool season grasses.

Fairways, Roughs, Sports Turf and Lawns:

Apply 13 - 35 litre (2.0- 3.7 gal/Acre) of Potassium+, 0-0-25, 17% Sulphur with 166 - 333 litre of water per Ha (44- 88 gal of water/Acre).

Apply 191 - 350 ml per 100 m² (6.0- 11.0 oz./ 1,000 sq. ft.) of Potassium+, 0-0-25, 17% Sulphur with 3.78 - 7.57 litre of water per 100 m² (1- 2 gal of water/1,000 sq. ft.) every 14 to 28 days throughout the growing season.
